

Notification with regard to the KYP New centre registration 2017 process post randomized lottery process dated 14-09-2017

Dear Applicant Organization,

This has a reference to your registration as a KYP SDC applicant on Bihar Skill Development Mission (BSDM) portal through the KYP SKILL DEVELOPMENT CENTER REGISTRATION 2017 process. At the onset we would like to thank you for showing interest in being a part of the skilling ecosystem in Bihar.

We had received an overwhelming response in KYP SKILL DEVELOPMENT CENTER REGISTRATION 2017 process wherein it had become logistically impractical and massively time consuming for us to conduct verifications of all the applicant centres prior to conducting the randomized lottery. Eventually to maintain the transparency and fairness in our approach a randomized lottery process was conducted on 9th September, 2017 through a software created by an independent and reputed Central Government entity i.e. NIC in the presence of a panel of esteemed / distinguished personalities of the Society including an Honourable retired Judge of Patna High Court and Vice Chancellor of Nalanda Open University and Media personnel. Through the randomized lottery process a total of 408 selections between 5168 randomization participants were done against the 408 centres required.

BSDM has received multiple requests from many of the selected applicant organizations in order to allow to get an alternate premise verified on the following accounts:

1. On account of the 2 months span between the registration commencement and eventual panel creation through a transparent & fair randomized lottery process the centre has been idle for this duration and thus many landlords have chosen to rent it out to other entities for other commercial / residential purposes. Thus the premise declared on the portal is currently unavailable for KYP SDC setup.
2. The applicants while declaring the centre details had selected premises based on approximate / ballpark estimates of 2/1 km rule compliance but now the centres have the measured distances from existing SDCs slightly less than the requisite mandate in many of the cases and thus a large representation of the applicants have requested that rejections in this case will be unreasonable.
3. Many applicants have requested for the same on account that the owners / landlords of the declared rented premise have now refused to allow the applicant to make any constructional changes as required under BSDM norms.

BSDM on account of the genuineness of the above requests of the applicants has decided to allow the selected 408 applicants to show an alternative premise for verification within the period communicated / stipulated by BSDM. The provision to change address shall not be a violation of the initially notified aspect of change not being allowed in the below stated fields:

- Organization Name
- Owner Name
- Registered Mobile Number
- Registered email Id
- Centre District, Block and Address
- Registered Bank Account

These fields as envisaged by BSDM need to be seen as a combination to establish the uniqueness of the applicant entity in order to prevent eventual sub-letting of the applied centres or trading of the centres successful in the randomized lottery process which was the main concern of BSDM while putting up the previous notice.

BSDM would like to intimate that all the 408 selected applicants through the randomized lottery process will have to complete the required declarations and get the required verifications done as per the stage wise deadlines on the BSDM portal. There shall be no extensions given to any applicant under any consideration unless otherwise decided by BSDM on account of any unforeseen circumstances.
